17 BETTY SEMBLER,

18 was adduced as the deponent herein, and being first
19 duly sworn upon oath, was questioned and testified as
20 follows:

DIRECT EXAMINATION

22 BY MR. MCGOWAN:

23 Q. Good morning, Mrs. Sembler. My name is Tom
24 McGowan. And I'll be asking you some questions today.
25 I'm sure your lawyers have told you a little bit about

1 the ground rules of your deposition.

2 Let me start by asking you whether or not you've
3 given a deposition before.

4 A. Yes, I have.

5 Q. Okay. Just so we understand one another, even
6 though this is a video deposition transcript, she
7 cannot take down things like a nod or an uh-huh or an
8 uh-uh, those kinds of things. So if your answer is
9 yes or no, please so state instead of, you know,
10 making gesture or something. People sometimes tend to
11 do that.

12 If you don't understand a question I ask
13 you -- sometimes I ask unclear questions -- tell me.
14 I'll try to rephrase it so you understand it.

15 A. Yes.

16 Q. For the record, could you please state your name
17 and address?

18 A. Betty Slesinger Sembler, 10324 Paradise
19 Boulevard, Treasure Island, Florida.

20 Q. Mrs. Sembler, what is your birth date?

21 A. August 8, 1931.

22 Q. And just briefly if you could tell us something
23 about your background and education starting with
24 college.

25 A. I'm a graduate of Northeastern University.

1 Q. Okay. What did you major in?

2 A. Latin American studies.

3 Q. Have you attended any post-graduate school of
4 any kind?

5 A. No.

6 Q. Okay. Do you serve on any boards of any
7 organizations?

8 A. Yes.

9 Q. Okay. Can you tell me which ones you're on at
10 this time?

11 A. I'm on the board of National Families and
12 Action, Atlanta, Georgia.

13 Q. Okay. What do they do? What is their --

14 A. It's a prevention organization.

15 Q. Preventing what?

16 A. Drug abuse.

17 Q. Anything else?

18 A. Yes, DARE.
